3. The object of the forfeiture allegation in the Superseding Indictment is the forfeiture to the United States of America of the real property described above.

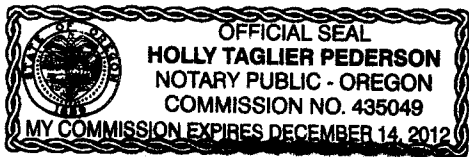
